- Faith's Lodge was occupied almost every week of 2021 and operated under strict standards to ensure the health of safety of guests.

 primarily through virtual visits from staff and providers. For 2022, expect
 a deeper focus on HWH and a fueled growth strategy as we continue to
 expand our network of employers.

They navigated challenges, overcame obstacles, and added new programming to meet the continued demand for our services. The staff continues to grow and develop with new members joining this month as well.

We know grief. Since opening our doors in 2007, we have served over 10,000 parents and their families, facing life's most difficult challenges. We offer two distinct programs to take away the isolation and provide hope.

LODGE PROGRAMMING

Faith's Lodge offers retreats with programming based on your child's age or circumstances. You will be connected with others who understand what you are experiencing. Our family and parent programming consists of optional activities including group and one-on-one discussions with a licensed grief therapist, therapeutic arts and crafts, mind/body wellness activities, and Northwoods adventures.




HOPE WORKS HERE




